Personal Loan Agreement

THIS PERSONAL LOAN AGREEMENT ("Agreement") is being made between Vanessa Wambui Karanja (the "Lender"), N.I.E Number: Y8367905J, Passport Number: YB5199261, with an address of Av. De Madrid, 149, Barcelona, Spain. and Edward Joseph James (the "Borrower"), N.I.E Number: Y4831951X, Passport Number: 120983566 with an address of Carrer d'Arizala 26, Primer, 08028, Spain on this day of Wednesday 12th April 2024.

IN CONSIDERATION THEREOF, the undersigned Lender and Borrower (collectively, the "Parties") agree to the following:

LOAN. The Lender agrees to lend the Borrower 20,000€ (the "Loan Amount") on the terms and conditions set forth in this Personal Loan Agreement. The loan will be sent to the following IBAN: ES85 2100 0506 1702 0033 1264, Name of the account holder: Edward Joseph James.

FINANCIAL OBLIGATION. The Borrower agrees that the amount owed to the Lender is 20,000€ ("Debt Amount").

PAYMENT PLAN. The Parties hereby agree that on the first day of June, the Borrower shall repay the Loan Amount of 20,000€. Subsequently, on the first day of August, the Borrower shall pay the remaining 40% interest on the Loan Amount which is 8,000€

Payment Method. The Borrower agrees to transfer the Loan Amount to the Lender's designated bank account. The payment should be made to the following IBAN: ES81 0182 0210 3402 0213 8245.

The transfer must be completed on or before the due date as specified in the Payment Plan of this Agreement.

The Borrower hereby represents and warrants that the aforementioned payment plan was created in consideration for the Borrower to be able to make their obligated payments without causing further indebtedness or detrimental circumstances.

INTEREST. The Loan Amount is subject to the following:	
[] The Borrower agrees to repay the Loan Amount in full plus an interest rate of 4	10 %.

LATE FEE. If any payment under this Agreement are 7 day(s) past due, the Lender will: [] Charge a late fee of 5 % of the payment owed for each following day the payment is late until the amount is repaid.

DEFAULT. In the event that the Borrower defaults on any payments and fails to cure the default within a reasonable amount of time, the Lender will have the option to accelerate and declare the entire remaining amount of the principal and any accrued interest to be immediately due and payable.

SEVERABILITY. In the event any part or provision of this Agreement is deemed unenforceable or invalid, in part or in whole, that part shall be severed from the remainder of the Personal Loan Agreement and all other parts or provisions shall continue in full force and effect as valid and enforceable.

DISPUTE RESOLUTION. Parties to this Agreement shall first attempt to settle any dispute through good-faith negotiation. If the dispute cannot be settled between the parties via negotiation, either party may initiate mediation or binding arbitration in the Province of Barcelona.

If the parties do not wish to mediate or arbitrate the dispute and litigation is necessary, this Agreement will be interpreted based on the laws of Catalonia and Spain. The Parties agree the dispute will be resolved in a court of competent jurisdiction in the Province of Barcelona.

The prevailing party to the dispute will be able to recover its attorney's fees and other reasonable costs for a dispute resolved by litigation or binding arbitration.

GOVERNING LAW AND JURISDICTION. The laws of Catalonia and Spain shall govern as to the interpretation, validity, and effect of this Agreement.

AMENDMENT, WAIVER, OR MODIFICATION. No provisions of this Agreement shall be amended, waived or modified except by any instrument in writing signed by all the parties hereto.

NO ASSIGNMENT. The Parties agree that they shall not assign or encumber their rights and obligations under this agreement.

ENTIRE AGREEMENT. This Agreement constitutes the sole and entire agreement of the Parties regarding the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, regarding such subject matter. This Agreement may only be amended, modified, or supplemented by an agreement in writing signed by each Party hereto.

COUNTERPARTS. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile. email, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

ELECTRONIC SIGNATURES. This Agreement and related documents entered into in connection with this Agreement are signed when a party's signature is delivered electronically, and these signatures must be treated in all respects as having the same force and effect as original signatures.

MISCELLANEOUS. This Agreement cannot be changed, modified, terminated, cancelled, rescinded, or in any other way altered or negated unless the same is in writing and signed by the party against whom enforcement of the change, modification, discharge, termination, cancellation, or rescission is sought.

It is agreed that all understandings and agreements heretofore had between the parties are merged in this Agreement, which alone fully and completely expresses their understanding, and this Agreement has been entered into after full investigation and consideration, neither party relying upon any statement or representation, not embodied in this Agreement, which may be claimed to have been made by any of the parties hereto.
